

**MINUTES OF THE
WEST BATON ROUGE PARISH PLANNING COMMISSION
Tuesday, August 17, 2010**

A regular meeting of the West Baton Rouge Parish Planning Commission was held on Tuesday, August 17, 2010, in the Parish Council Meeting Room, 880 N. Alexander Avenue, Port Allen, LA. The meeting was called to order by Chairman John Tilton at 6:44 PM.

Motion was made by Teri Blanchard seconded by Bobby Blanchard, to approve the minutes of the August 3, 2010, meeting. Motion carried unanimously.

Public Hearing:

- 1) File #2010-027 Final map showing subdivision of Lot 12-A-2 of Burnside Plantation into Lot 12-A-2-A and Lot 12-A-2-B, Section 9 & 10 T6S, R11E, West Baton Rouge Parish, LA. For Heath Morris.

For Heath Morris. The motion carried unanimously.
